FINALE® END USER LICENSE AGREEMENT

IMPORTANT - READ THIS AGREEMENT

This End User License Agreement (the "Agreement") is a binding agreement between MakeMusic, Inc. ("MakeMusic") and you.

YOU AGREE TO BE BOUND BY THIS END USER LICENSE AGREEMENT THROUGH YOU INSTALLING FINALE ON YOUR DEVICE. IF YOU DO NOT AGREE TO THE TERMS AND LIMITATIONS OF THE AGREEMENT, YOU MAY NOT INSTALL OR USE THE SOFTWARE.

A copy of this Agreement can be found at https://www.makemusic.com/terms-conditions/. From time to time, MakeMusic may change the terms in the Agreement. When the terms are changed, MakeMusic will post a notice online. The changes also will appear in this document, which you can access at any time through https://www.makemusic.com/terms-conditions/.

MakeMusic is licensing a specific major version of the FINALE® software program, including but not limited to (a) all software files and other computer information, (b) any proprietary scripting logic, (c) musical content, resource files and templates, (d) fonts, and (e) any updates and improvement to the version you originally downloaded (collectively, the "Software") and all related documentation materials ("Documentation") to you on the following terms and conditions:

1. GRANT OF LICENSE. In consideration of the license fee you paid for this product, MakeMusic grants you, as licensee, a worldwide, limited, revocable, non-exclusive right to install, reproduce, and use the Software and Documentation on two (2) operating systems under the terms and limitations of the Agreement, either one operating system each on two different computers or two operating systems on a single computer.

However, a supplemental Site License Agreement may strictly limit use to the number of computers specified on that agreement. If the serial number associated with your license has been registered under individual ownership, you are the sole authorized user of the Software on those computers authorized under your license agreement. If the serial number associated with your license has been registered under organizational ownership, your organization must designate a sole authorized user.

For individual licensees, the Agreement is the complete and exclusive agreement between you and MakeMusic relating to the Software. A supplemental Site License Agreement may also be in effect for some licensees. The Agreement along with the supplemental Site License Agreement shall be interpreted under the laws of the State of Colorado applicable to contracts made in Colorado.

- 2. LICENSE FEE. In consideration for your licensed use of the Software, you agree to pay the license fee for accessing and using the Software. The current standard retail and academic license fees are listed during check out and are available at https://store.makemusic.com/.
- 3. OWNERSHIP. The Software and accompanying documentation materials may also be protected under federal copyright and other intellectual property laws. Unauthorized copying or use of the Software beyond the scope of the Agreement is expressly forbidden. You may be held legally responsible for any copyright infringement or infringement of any other intellectual property right that is caused or encouraged by your failure to abide by the terms and conditions of the Agreement. The Agreement is NOT a sale of the Software. MakeMusic retains all ownership and rights in the Software, including all rights in any portion(s) of the Software present in any output of the Software.
- 4. **USE RESTRICTIONS.** As an individual licensee, you may physically install the Software on two (2) operating systems as defined in Section 1 (Grant of License). Site License licensees may install the Software on only the number of computers allowed in the supplemental Site License Agreement. As an individual licensee, you may not install or use the Software on a network, more than two (2) computers, multiple site arrangement, or any other hardware configuration where the Software is accessible to more than one computer or to more than one user at a time. You may not use telecommunication transmissions to electronically transfer the Software from one computer to another. To protect MakeMusic's copyrights and trade secrets in the Software, you may not adapt or make alterations to the Software, decompile, disassemble, translate, convert to another programming language or otherwise reverse engineer the Software. - share user licenses as each user must register with the Software;

- transmit, share or otherwise make available any material that contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer software or hardware or telecommunications equipment; or
- transmit, share, store or otherwise make available content that would constitute,

encourage or provide instructions for a criminal offense, violate the rights of any party, or that would otherwise create liability or violate any local, state, national or international law.

- 5. TRANSFER RESTRICTIONS. You may not transfer, assign, sell, or otherwise dispose of this license to the Software on a permanent basis without the written permission of MakeMusic. Should MakeMusic grant such permission, you will be required to (a) pay a Transfer Fee in effect at the time of the transfer, (b) relinquish all authorizations and copies of all versions of the Software associated with the transferred serial number, and (c) upgrade to the most current major version of the Software if not already licensed. - 7. **TERMINATION.** The Agreement is effective upon installation of the Software and remains in effect until expiration of all copyright interests in the Software, unless earlier terminated. The Agreement shall terminate automatically without notice from MakeMusic if you fail to comply with any of the terms or limitations of the Agreement. Upon termination you must return all copies of the Software to MakeMusic. MakeMusic may terminate your license to the Software upon your breach of this EULA. MakeMusic may provide you an opportunity to cure such breach prior to termination in its sole discretion, but has the right to terminate the agreement immediately for any material breach of this Agreement.
- **8. COPY RESTRICTIONS.** You may make one copy of the Software either digitally or on physical media solely for backup purposes. The backup copy automatically becomes the property of MakeMusic and is subject to the Agreement. You must reproduce MakeMusic's copyright notice on the backup copy.
- **9. AUTHORIZATION.** You have 30 days from date of installation of the Software to authorize each copy of the Software. The first time you launch the Software, you will be prompted to authorize the Software via an Internet connection. If you choose not to authorize, you will be prompted to do so each time you launch the Software. If authorization is not completed within thirty days, printing and saving are disabled until you choose to authorize.
